Exhibitor Liability and Waiver Information

Liability, Waiver and Release Information

Your registration as an Exhibitor (Exhibiting Vendor) indicates agreement to assume responsibility and to hereby release Hotel, Hyatt Regency Hill country Resort and Spa, the entity that owns the hotel, the entity that manages the hotel and their affiliates and each of their respective shareholders, members directors, officers, managers, employees and representatives, ARK Enterprises LLC, d/b/a Utility Payment Conference, its exclusive PSAV, our Electrical and Internet Provider and Freeman, our AV and exclusive Exhibit Booth Set-up Company (released parties) harmless from and against all claims, costs, losses, expenses damages, actions, causes of action and/or liability, including reasonable attorney's fees, arising out of or resulting from all liability as a result of its actions during the event, provided that such liability was not caused by the Utility Payment Conference (ARK Enterprises, LLC) or the providers listed above.

The Exhibiting Vendor shall indemnify, save and hold harmless the Released Parties from and against, all claims, losses and damages, injuries, awards, fines, government charges and liability; together with all costs, expenses and reasonable attorneys; fees in connection with its gross negligence and willful misconduct at the Utility Payment Conference (Conference), its activities and Exposition. The Conference requires all Exhibitors to provide a Certificate of Insurance for the Utility Payment Conference listing the name of the Exhibiting Company and its Parent Company with a 30-day notice of cancellation provision effective for September 16 – September 19, 2019.

One insurance certificate is requested of the Certificate Holder: Certificate language should be listed as follows:

The Certificate shall provide evidence of commercial general liability coverage with limits of \$2,000,000 per occurrence, with a \$5,000,000 general aggregate to include coverage for independent contractors, personal injury and blanket contractual liability for Hyatt Hotel, ARK Enterprises LLC, d/b/a Utility Payment Conference, PSAV, Electrical and Internet Provider, and Freeman Exhibitor Booth Set-up and AV Company, and it's Released Parties, listed as additional insureds on this policy for the period September 16 – September 19, 2019. Minimum coverages required are as follows:

Commercial General Liability Type of Insurance: Providers minimum coverage

Each Occurrence: \$2,000,000

Damage to Rented Premises: \$2,000,000

General Aggregate: \$5,000,000

Workers Compensation/Employer's Liability Type of Insurance: Providers minimum coverage

E.L. Each Accident: \$2,000,000

Automobile and Umbrella: Providers minimum

The Exhibitor agrees to comply with all union regulations and to abide by all agreements between the Utility Payment Conference and its contractors, including the Hotel, the Trade Show Service Provider, electrical and audio-visual companies or any of its agents.

The Certificate of Insurance must be received by the Utility Payment Conference no later than August 15, 2019.
